### 3. PRODUCT DESCRIPTION

Dynabinder CRA is a factory mixed product for use as an adhesive for tennis court crack repair systems. A precise blend of court patch binder and resurfacer, it eliminates the need for field mixing, resulting in a more accurate mix of the adhesive portion of the crack repair system.

Packaged in 5 gal. pails, 30 gal. kegs and 55 gal. steel drums.

#### Color:

#### Basic Uses:

Dynabinder CRA is specifically designed to work with Crack Repair Systems for superior bonding with existing asphalt or concrete surfaces and the Crack Repair System fabrics. Dynabinder CRA can also be used in the seaming of sport mat systems of all kinds and is also used with fiberglass mesh or fabric to encapsulate and solidify repaired areas.

#### Composition:

Dynabinder CRA is a factory mixed high tensile strength, acrylic latex bonding agent and a premium quality non-pigmented acrylic emulsion. This product is also formulated with a surfactant package which promotes superior adhesion to both concrete and asphalt surfaces. Dynabinder CRA contains no asbestos or mercury

#### Limitations:

In the liquid state, Dynabinder CRA must be protected from freezing and rain. Do not store in direct sunlight or where temperatures exceed 120 F.

### 4. INSTALLATION

Dynabinder CRA is intended to be used with commercially available crack repair systems for tennis courts. Refer to the instructions provided by the specific Crack Repair System manufacturer. Dynabinder CRA is ready to use. Stir contents and apply as directed by specific Crack Repair System instructions. Do not dilute.

#### Precautions:

Liquid Dynabinder CRA must be protected at all times from freezing. Keep out of reach of children. Container should be closed when not in use. Avoid breathing vapor or contact with skin or eyes. Do not apply when rain is imminent. Consult the specific Neyra Safety Data Sheet before use.

New asphalt should be allowed to cure for a minimum of 15 days prior to application and must not exhibit ribboning, crawling, nor show oil rings when 1 gallon of clean water is poured onto the surface.

New concrete pavement should be allowed to cure for a minimum of 30 days prior to application.

### 5. MAINTENANCE

Proper care of the finished surface will maintain the attractive appearance and prolong the service of the Dynabinder coating system. Keeping leaves and other foreign matter off the surface and occasional flushing with clean cold water will achieve good results.

### 6. TECHNICAL DATA

#### Environmental Considerations:

Dynabinder CRA is non-hazardous when tested according to the EPA's TCLP (Toxicity Characteristic Leaching Procedure). Dynabinder is a water-based material containing less than 7 g/L (0.06 lbs/gal.) VOC content.
